Scope 1.1

This document defines the specific safety requirement for AW09 suppliers.

1.2 Summary and purpose

The complete set of safety requirements that each supplier commits to fulfil for providing Articles and/or Services are described in the main LH document (SRS-01 Safety Requirements for Suppliers).

The present document clarifies the specific applicability and exclusions of SRS-01 Requirements.

The present document and the applicable SRS-01 modules enable Kopter to flow-down to AW09 suppliers the Kopter commitment to safety, described in the Kopter Group Safety Policy [Ref 1].

1.3 **Applicability**

The present document "SRSK-01 – Safety Requirements for AW09 Suppliers" is applicable to all types of suppliers having an activity related to the program AW09 and affecting the airworthiness. These requirements shall be flowed-down to all sub-tier suppliers involved in fulfillment of the AW09 contract/purchase order.

When SRS-01 and/or SRS-XXX modules are called out in a AW09 purchase order, the present document ("SRSK-01 - Kopter Safety Requirements for Suppliers") is also applicable and the SRS-XXX modules apply according paragraphs 2 and 3.

The requirements defined in the present document prevail over SRS-01 requirements when there is a conflict
