### Leonardo's anti-corruption leadership confirmed with management system certification renewal

**Rome, 19/07/2024** – Leonardo has been confirmed as a leading company in the fight against corruption. The company's commitment against bribery and enhancing the related risk prevention system, in the area of global security technologies, are the main factors behind the renewal of the Anti-Corruption System Certification, which was issued by RINA, pursuant to the standard ISO 37001:2016 "Anti-bribery Management Systems"- the first international standard in the sector.

Based on the checks carried out by RINA, all Leonardo processes exposed to the risk of corrupt conduct are compliant with the internal control system. This demonstrates the full maturity of an approach in line with global best practices.

A key element of the recognition is the awareness of the Group's employees of an internal system for the prevention of corruption and the progressive implementation of corporate control measures, with a view of continuous improvement.

Leonardo achieved Certification for the first time in 2018, placing itself in the leading group of top ten international Aerospace, Defence & Security companies in possession of the recognition. The company system is subjected, on an annual basis, to surveillance activities by the external certifying body.

With 53,000 employees worldwide, the company approaches global security through the Helicopters, Electronics, Aircraft, Cyber & Security and Space sectors, and is a partner on the most important international programmes, within these sectors, such as Eurofighter, NH-90, FREMM, GCAP, and Eurodrone. Leonardo has significant production capabilities in Italy, the UK, Poland, and the USA. Leonardo utilises its subsidiaries, joint ventures, and shareholdings, which include Leonardo DRS (72.3%), MBDA (25%), ATR (50%), Hensoldt (22.8%), Telespazio (67%), Thales Alenia Space (33%), and Avio (29.6%). Listed on the Milan Stock Exchange (LDO), in 2023 Leonardo recorded new orders for €17.9 billion, with an order book of €39.5 billion and consolidated revenues of €15.3 billion. Included in the MIB ESG index, the company has also been part of the Dow Jones Sustainability Indices (DJSI) since 2010.
